Pointed to the guidelines - Group has been changing processes by doing this inventory - Bring up ideas, questions, suggestions at group biz meeting - Suggestion: <ul style="list-style-type: none"> - don't do a group inventory when a new person at meeting - choose a different day from meeting day to do group inventory - Suggestions/Comments: <ul style="list-style-type: none"> - Taking one inventory question per month - Can take an inventory at any time instead of confronting person causing issues - Review to find those that the group is already doing and doing well. <p>How to Complete Your Meeting Where did our Literature table go?</p>	<p>Denize, Earl and Brooke</p> <ul style="list-style-type: none"> - Not receiving many orders from electronic meetings - In-person meetings beginning to order CAL again - Per Brooke: many perks to being the HALC Coordinator: attend Assemblies and Conferences for free. Brooke will be of service to new Coordinator. You will not be alone - Q/Comment: The HALC Coordinator must live on Oahu? - A: Yes - Q: HALC Coordinator position begins when? - A: As soon as someone steps up. It's a 3-year commitment. Brooke has been doing it for 10 years - Tanya also volunteered and conceded to Mary and Akemi - Q: Can you order literature from Amazon? - A: That's not an approved source. Not sure where Amazon is getting the literature. Proceeds from buying from Amazon does not go to the WSO - During the Pandemic, moneys were donated from Big Island and the Area to pay for book storage. <p>Tech Q&A</p>	<p>Nathan, Website Coordinator</p> <p>How to handle an unwanted guest on Zoom (“Zoom bomber”):</p> <p>When in your Zoom meeting:</p> <ul style="list-style-type: none"> -Go to participants -Claim Host: you will need a Host code/key, make sure that is shared with those who chair/secretary the meeting. Keep the code confidential, sharing it only with those trusted to host the meeting. Do not make the code/key publicly available -As Host, move your cursor over the image of the offending person -click on the 3 dots (...) -Choose “Remove (Name of person) -A pop up box will prompt you to Remove (there is also a choice to report the person to Zoom) -The person will be removed from the meeting and will not be able to rejoin the meeting 	<p>Nathan has been posting Guidelines on the Hawaii area website. If they use another device, they will be able to rejoin</p> <p>Q: Can you close the person’s camera?</p> <p>A: Yes, when you’re the host. You can turn off the person’s camera, you can mute the person and you can remove them from the meeting. You can also put the offending person into a waiting room</p> <p>Comment: One AFT put the Host Key in the script with the proviso: “Please only use the Host Key if absolutely necessary”</p> <p>Q: Is there anything you can do if you’re just a guest on Zoom.</p> <p>A: No, there’s nothing you can do</p> <p>Q: Can you claim Host from another host?</p> <p>A: Whoever has the Host code/key, can claim Host. The Host can assign someone else to be Host or Co-Host</p> <p>Comment: Don’t know how to unclaim host.</p> <p>A: How to do that:</p> <ul style="list-style-type: none"> - In Participants, move your cursor over the name of the person you want to make host, click “Make Host”. You can also click the “More” box and you can make someone a Co-host - As Co-host, you cannot kick another co-host off the meeting. You can mute and turn off the video of a co-host - Comment: It is not a good idea to make the host key accessible to just anybody. Keep it secure and provide it only to those who have secretary/chair responsibilities in your group - Q: what if the bad participant is a disgruntled member who gets kicked out of the meeting but is allowed back later? - A: They can rejoin at the next meeting. They are kicked out of the current meeting only and cannot rejoin the current meeting - Q: If the Zoom ID is changed for each meeting, can the bad person still get in? - A: Not if they don’t know the access code to join the meeting for each meeting - Q: What if the Group doesn’t know their Host key/code? - A: Need to ask the Zoom help - Comment: Zoom does have an “Abuse/Hateful Content” Policy. - A: That “Contact Zoom” button gives Zoom the ability to permanently block someone
