



The WSO will register groups with names that designate them as being for men, women, parents, adult children, young adults, other gender identification/sexual orientation, etc. with the understanding that, in keeping with Traditions Three and Five, the groups will welcome anyone affected by someone else's drinking.

Delegates Speak

- The Policy change created controversy.
- What kind of complaints did the WSO receive regarding the Policy change?
- We should talk more about the history of why the policy change was made.
- What is controversial about a certain designation in a group name?
- We have not had enough time to get input from our Areas about this Policy change.

WSO Asked Delegates...

Do you think the issue is the Policy itself, or the implementation of the Policy?

The Response

The majority of the Delegates came to the conclusion that the issue was with the implementation of the Policy and not the Policy itself.

Where Do We Go From Here?

- The Policy Committee Chair Asked if the Delegates were prepared to discuss the implementation process of the Naming A Group Policy?
- Delegates still felt we did not have enough information from the groups to begin the discussion on implementation.
- The Policy Committee asked to further review everything up until this point and return to the Conference with a response.

Day 4 - WSO Responds - Policies Chair Makes a Statement

"It was never the Policy Committee's intention to direct the WSO Staff to enforce the Policy on existing groups, never, ever."

The Motion Made by the Policy Committee:

Allow group names to continue to include identifiers such as those currently listed on page 28 of the 2022-2025 Al-Anon/Alateen Service Manual (P-24/27) v4(a) including "men, women, parents, adult children, young adults, other gender identification/sexual orientation, etc. with the understanding that in keeping with Traditions Three and Five, the groups will welcome anyone affected by someone else's drinking" until the 2026 World Service Conference to allow WSC Structure Areas to discuss the implementation of the 2024 WSC-approved "Choosing a Group's Name" Policy.

GR Assignments

- Clarify for your groups that the <u>Policy will remain as it is</u>.
- Also, clarify for your groups that as the Statement of the Policy Chair states, this has nothing to do with existing groups. This pertains only to new groups and groups who want to change their names.
- Gather your group's concerns, thoughts, and opinions on implementation and the Policy through spiritual conversations with the group.
- Remind your group: <u>We must welcome everyone affected by someone else's drinking, regardless of what our group name is.</u>

Single Process Trustee Selection

Proposed Process for Regional Trustee Selection

Discussion Framing - con't

- Under the current nominating process it is easier for members to apply for Trustee at Large than Regional Trustee.
- This is partly due to the fact that a Regional Trustee applicant must go through Area approval before the application can be submitted.
- Applications for Trustee at Large are not submitted to Area approval.

Regional Trustees

- Sit on the Board of Trustees representing their Regions. In Hawaii's case, the Southwest Region that also includes California North, California South, Nevada, Colorado, New Mexico, Utah, Arizona, and at present, the Global Electronic Area.
- See page 173 of the current Service Manual

Discussion Framing

Why Change the Process?

- Over the Past 20 years the Board of Trustees has been operating at 88% capacity in terms of elected Trustees.
- In the last 5 years that percentage has dropped to 72%.
- With technology expansion, legal threats, evolving cultural awareness, and cyber security concerns, there is increased pressure on existing Trustees, or work must be deferred.

Comparisons between Current and the Single Process Trustee Selection

Current

- Applications for Regional Trustees must be reviewed and approved by the Area and forwarded to the WSO by the Delegate.
- The Area may submit comments about the applicant, negative or positive for review.

Single Process

- Applications for Regional Trustees bypass Area Approval and go straight to the WSO to go through the process.
- The applicant will be review for their skills and not the person.


Your Task as an Area
