Another member recited the prayer in Spanish. It was so interesting to meet other archives coordinators from all over the United States, Canada, and Puerto Rico.

We can use these as guidelines to record and preserve our local history. I distributed informational packets to GRs at a recent Maui District Meeting. My hope is GRs take these back to their groups and be inspired to record their own Group Histories and learn more about the origins of Al-Anon both nationally and locally.

My goal at Fall Assembly is to share Archives resources to spark interest in the history of Al-Anon and talk about what it means to preserve the documents, histories, and memories (particularly of long-time members) that help tell the story of Al-Anon in Hawaii. In the process, I hope to form an Archives Committee to help me chart a path toward collecting, organizing, and digitizing our history so that it is accessible to our fellowship.

## Web Coordinator Report – October 20, 2024

Aloha mai kākou,

It's been a busy several months of settling in since my last report.

On average our website sees 33 visits a day. The majority of visits are between 08:00 am and 8:00 pm with peaks between 5:00 pm and 7:00 pm Monday through Thursday, Wednesday morning and Thursday noon, which implies that most hits are people checking the schedules as there are more meetings at these times.

Our hosting provider estimates that 86.5% of hits in the last 90 days were first time visitors to the site.

The majority of messages I get through the 'Contact us' form on the website are from people who are new to Al-Anon and looking to attend their first meeting. Some of these are also asking for more information about what to expect, others are just asking where to find information about meetings.

Keeping the website updated is going smoothly, although it tends to go in spurts, with no requests coming in for a couple weeks then a bunch come in all at once. I like to get things updated asap, but sometimes it takes me a few days to catch up.

I also put together a slideshow presentation/pdf about how to deal with zoom bombers.

Future projects I am planning are:

Adding searchable archives for past area documents dating back as far as we can find to the website, and possibly digitizing any older paper documents we can find. I think this is important as it enables us to understand the historical conversations and group conscience that lead us to our current policies. Understanding our history enables us to make better decisions for our future.

Building the pages for each District to be more informative and useful for the unique needs of each district.

Possibly adding information to coordinator pages.

In moving forward with any projects it's important to keep an eye to the future by being conscious of the difficulty in filling the Web Coordinator position by not adding anything that will be complicated or difficult to maintain by my eventual successor.
